Abstract:	Records consist of documents created and collected by Valentine and Anna School. They include the personal papers of Valentine - a coal miner and resident of the Village of Hackett, a photograph album compiled by his wife Anna, circa 1925-1950, financial documents relating to Valentine's role as treasurer of the Hackett Giants Baseball Club from 1934-1935, and records he created as the manager of the City Line Texaco service station in Washington, Pennsylvania from 1958-1965.

Biography/History

Valentine School (1903-1993) was a lifelong resident of the Village of Hackett in Washington County, Pennsylvania. His parents Aloysius (Lewis) and Katherine Gregerich School immigrated to the United States from Hungary in 1890. Valentine's younger siblings were Katherine and Thomas.

Anna Rose Vrhovsek (1909-1986) was born in Europe and immigrated to the United States with her family in 1913. She was the eldest of Joseph (1883-1952) and Anna (née Pernisek) Vrhovsek's children. Her siblings were Joseph, Mary, Johanna (Jennie) and Frances. Prior to marrying, Anna lived with her family in Troy Hill on Pittsburgh's North Side.

Anna and Valentine married on June 17, 1936 and resided in Hackett. They had three children: Edwin (born 1937), Betty Ann (born 1940), and Mary (born 1943).

Valentine worked as a coal miner and later as the manager of the City Line Texaco service station at 74 Murtland Avenue in Washington, Pennsylvania. Valentine played the position of catcher for the Hackett Giants Baseball Club and served as its treasurer from 1934-1935.

Collection Scope and Content Note

The collection documents Valentine and Anna School's life in Hackett, including gasoline rationing during World War II and Valentine's applications for employment benefits during 1941 and 1954. The collection also documents Valentine's membership in various social clubs, his role as the treasurer of the Hackett Giants Baseball Club from 1934-1935, and his position as the manager of Washington's City Line Texaco service station from 1958-1965.

The collection includes numerous photographs of Anna and Valentine's family and friends. Textual documents include membership cards, licenses, gas ration stickers, Valentine's Pennsylvania Employment Service identification cards, receipts, a record of donations to the baseball club and of dues paid by its members, a score book from the 1934 season documenting the Giants' games against other area baseball teams, and a ledger recording repairs completed by City Line Texaco and the hours worked by its employees.

Subseries Scope and Content Note: Subseries includes one photograph of Valentine with a catch of fish and additional photographs of unidentified people. Subseries also contains receipts for payment of taxes from 1921, 1923 and 1932, and a notice of the delivery of leased furniture from Gimbel Brothers, 1933. It also includes a ledger used by Valentine for multiple purposes between 1935 and 1943. The information recorded in the ledger includes a roll call, a list of individual contributions to a picnic, and what appears to be a list of items purchased by

individuals at the Schools' store in Hackett. The ledger also records expenses, days of work, boards cut, and the number of Valentine's miner's certificate issued on February 16, 1938. Subseries also includes a 1970 copy of the *Constitution of District No. 5 United Mine Workers of America* and a blank undated postcard of Veszprém, Hungary where Valentine's ancestors lived.

Subseries ii. Valentine School wallet and contents, 1938-1972

Subseries Scope and Content Note: Subseries consists of Valentine's Loyal Order of Moose wallet and its contents. Valentine was the Dictator of the Finleyville Moose Lodge No. 172 in 1938. The contents of the wallet include social club membership cards, automobile and fishing licenses, newspaper articles, WWII mileage ration stickers, and applicant cards for the Pennsylvania State Employment Service.

Series II. Hackett Giants Baseball Club treasurer's records, 1934-1935

Series Scope and Content Note: Series consists of records created and received by Valentine School in his role of treasurer of the Hackett Giants Baseball Club. Series includes receipts of payment from local area businesses for equipment, food and services purchased by the Hackett Giants Baseball Club. It also includes what appears to be a list of used baseball equipment donated to the team on August 21, 1934 by Frank Beckenger.

Series also contains handwritten receipts of payment by the club for services including ball diamond scraping and grass cutting, transportation to games and telephone calls. Series also includes checks written by the club as payment for products and services, and a Compositions book containing a list of donations made to the team, as well as a record of team members and the collection of their weekly dues.

Series also includes a *Simplex League Score Book No. 4* created by the Rawlings Manufacturing Company in St. Louis, Missouri documenting the club's games from June 28-August 26, 1934. During this time, the Giants played teams from Allison, Venetia, Hendersonville, Muse, Gastonville, Beadling, Cloverdale, Snowden, Riverview and New Eagle.

Series III. City Line Texaco service station records, 1958-1965

Series Scope Content Note: Series consists of a certificate granted to Valentine School on completion of the *Allen Power-Tune Course of Modern Engine Servicing*, 1958, a membership card for safe driving in the name of City Line Texaco, 1958-1959, and of a ledger documenting vehicle servicing and employee hours between 1959 and 1965 at the City Line Texaco service

station located at 74 Murtland Avenue in Washington, Pennsylvania where Valentine worked as a manager.
