# **Biography/History**

Carol-sue Dukstein (1936-2014) of McMurray, Pennsylvania, was a well-known artist in the South Hills of Pittsburgh. Dukstein was a founding member of the McMurray Art League, a non-profit community organization whose members exhibit art works at the Peters Township Public Library.

## **Scope and Content Note**

Records include four matted pen-and-ink (ink on Bristol) drawings of landmarks in and around Peters Township created by Carol-sue Dukstein in 1975 and 1976. The drawings (14cm x 11cm) are entitled "Mingo Bridge", "Little Lake Theatre", "View from Peterswoods", and "New Library".

The collection also includes lithographed notecards created from each of the drawings and sold by the Friends of Peters Township Library in 1976 to raise funds to purchase shelving and other furniture for the township's new library building. A copy of a *Pittsburgh Press* newspaper article from April 6, 1976 entitled "Artist Sketches Aid for Library in Peters Twp" is also included.
